- **1. PRELIMINARY SCHEDULES**: A schedule of soccer scrimmages, tournaments, and season games, including the date, time, location, level (Varsity, Jr Varsity, Jr Varsity 2) gender, home and away teams, must be submitted to the Soccer Assignor no later than October 1st of the beginning of the season. - **3. CHANGES to SCHEDULES**: Any changes to the schedule must be submitted, as soon as possible, by email to Mickey O'Brien at refmickey.obrien@gmail.com.
- **4. ALL GAME DAY CANCELLATIONS:** Any game day cancellations, including extreme weather, field conditions or transportation issues must be cancelled by email notification to both assignors; Mickey O'Brien at refmickey.obrien@gmail.com Cancellation must be made a minimum of 3 hours prior to kick off time so game officials can be appropriately notified. In the case a game is cancelled by a coach, a district athletic office or the school district due to extreme weather, field conditions or transportation issues and the TASO Tarrant Soccer Assignors were not notified in sufficient time to prevent the game officials from traveling to the game location and game officials arrive to the venue, the game officials will be paid their first game fee for their assigned game position and mileage reimbursement for their travel.
